FOREIGN SUPPLIER'S REGISTRATION REQUEST

I. - APPLICANT COMPANIES MUST PROVIDE THE FOLLOWING DOCUMENTS:

- a) Letter to Commander of the Logistics Command of the Chilean Air Force requesting the register of the company. (Form No 1).
- b) Application Form, indicating the commercial information of the Applicant Company. (Form No 2).
- c) A special "Power of Attorney" stating the personality of the applicant company's agent or representative (CEO, CFO, GENERAL MANAGER, ETC.), authorized to sign contracts and accept purchase orders on its behalf.
- d) Legal paperwork (Corporate Certificate, Certificate of Status, Certificate of Good Standing), showing that the applicant company is legally constituted and registered in the commercial register of its State or Country.
- e) Affidavit, granted by the company's agent or representative (CEO, CFO, GENERAL MANAGER, ETC.) stating that the applicant company does not incur in any of the causes of disability and abstention detailed in the affidavit, and indicating any other Supplier Registry in Chile where the applicant company is currently registered. (Form No 3).
- f) Products & Services form, mentioning what the applicant company manufactures, produces or distributes for offering to the Chilean Air Force. (Form No 4).
- g) Letter of Representation, indicating the individual or Chilean company that holds the representation of the applicant company in Chile. (If applicable).
- h) List of people who hold the representation of the applicant company in Chile, indicating the names of their partners, owners, managers, directors and executives. (If applicable).

II. - REMARKS

- a) LEGALIZATION:
 - If the applicant company is located in a country member of "The Hague Apostille Convention", the requested documents mentioned in letter c), d), e) and g) must be "Apostilled" by the respective State authority.
 - If the applicant company is NOT located in a country member of the "The Hague Apostille Convention" the requested documents mentioned in letter c), d), e) and g) must be legalized before notary as well as by the Chilean Consulate.
- b) VALIDITY
Documents should have an issuance date not longer than one hundred and twenty days (120) counting since the date of the submission of the request.
- c) LANGUAGE
Documents should be officially translated into Spanish unless they are written in English language.

in order to satisfy the requirements of Special Supplier Registry of the Chilean Air Force, in accordance to the regulations stated in the Supreme Decree of the Ministry of Defense. SSFFAA. N° 746, dated on **October 18th, 2011**, published in the Chilean Official Newspaper on May 22nd 2012 and modified by Decree N° 606 dated on November 2nd, 2016, published on Chilean official Newspaper on April 18th, 2017, hereby deposes and says:

- I. The company that I represent has not been judicially resolved any contract with the State Administration in the last two years.
- II. - Not to incur in any of the following causes of disability and abstention:
 - a) To have been sentenced for any of the bribery offenses referred in Book II of the Chilean Criminal Code: Title IV: "Of the crimes and simple crimes against the public faith, of the forgeries, the false testimony and the perjury", Paragraph 2°, 4°, 5° and 7°; Title V: "Of the crimes and simple crimes committed by government employees in the performance of their duties", Paragraph 4°, 5°, 6°, 7°, 8°, 9°, and 10°; Title VI: "Of crimes and simple crimes against public order and security committed by individuals", paragraph 5°, 7° and 8°, with the exception of Art. N° 288 bis and paragraph 14°; Title IX: "Crimes and simple crimes against property", paragraph 7° and 8°.

To have been sentenced for any of the bribery offenses referred in Decree No. 211 OF 1973 related to free market competition.

To have been sentenced for any of the crimes sanctioned in the Tributary Code, in the Military Justice Code or in the Decree N° 30 of 2004 of the Ministry of Finance, regarding to Customs Regulations.
 - b) To have one or more tax debt registration in Chile for a total amount superior to 40,000 USD for more than a year or between 16,000 and 40,000 USD for more than two years without a payment agreement in force.
 - c) Register debt with the Chilean Social Security Administration for more than twelve months for its dependent workers.
 - d) To have submitted to the Special Supplier Registry of any branch of the Chilean Ministry of Defense one or more documents which were later declared false.
 - e) Be submitted to insolvency proceedings to which the Law No. 20.720 refers, to a bankruptcy trial or to the dismantling of their assets.
 - f) To have been convicted to anti-union practices or violation of the fundamental Chilean rights of workers.

- g) Be subject to prohibition of celebrating contracts with the Chilean State Authorities in accordance to Article 8, paragraph 2, and Article 10 of the Chilean Law N° 20393 of year 2000.
- h) Provide personal services at the Chilean Air Force as an employee.
- i) To have relationship of marriage, adoption or kinship up to third degree of consanguinity and second degree of affinity, with the high authorities of the Chilean Air Force.
- j) To have among its business partners, stockholders, managers, representatives or directors, a person that has been affected by any of the conditions referred to this clause or be touched by any of the circumstances indicated in the final section.
- k) Have the status of accused or as the accused against whom the investigation has been formalized, in respect of one or more of the offenses mentioned in letter a) of this article, in accordance with the provisions of articles 274 and following of the Criminal Procedure Code, 229 and following of the Criminal Procedure Code or the Book II of the Military Justice Code.
